The Exeter City Council met in regular session on March 13, 2018, at 7:00 p.m., in the Council Chambers of City Hall, located at 137 North F Street in Exeter. Mayor Boyce called the meeting to order. Ted Macaulay addressed the Council on behalf of Janis Macaulay and submitted a letter to the Council requesting a exemption from the City of Exeter's water restrictions to allow use of water slide and slip and slide at the end of the year party at Rocky Hill Elementary School. Mr. Macaulay also addressed the Council regarding item B3 and provided his support for the Visalia/Caldwell corridor.

B-1 Public Hearing to adopt Resolution 2018-06 Adopting the City of Exeter's updated Urban Water Management Plan. Mayor Boyce opened the public hearing at 7:16 p.m., receiving no public comment, Mayor Boyce closed the public hearing at 7:16 p.m. Following brief discussion, it was moved by Council Member Sally, seconded by Mayor Pro Tem Waterman-Philpot and unanimously carried to adopt Resolution 2018-06 as presented.

City Engineer Lisa Wallis-Dutra provided a PowerPoint presentation highlighting the Non-Motorized Corridor Feasibility Study report for Council's review and consideration. Following discussion, it was moved by Council Member Gerdes, seconded by Mayor Pro Tem Waterman-Philpot and carried 4-1 (Council Member Sally voting no) to support moving the funds for a Class 1 Trail to an alignment along Visalia Road/Caldwell Avenue from Visalia to Exeter.
