The Exeter City Council met in regular session on July 24, 2018, at 7:00 p.m., in the Council Chambers of City Hall, located at 137 North F Street in Exeter. Mayor Boyce called the meeting to order. Following the pledge of allegiance, John Jimmeye led the invocation. Roll call showed Gerdes, Petty, Waterman-Philpot and Boyce present.

City Attorney Julia Lew provided additional information regarding the vacancy and appointment for Council's consideration. It was further moved by Mayor Pro-Tem Waterman-Philpot, seconded by Council Member Petty and unanimously carried to request a letter of interest from Barbara Sally and set appointment for next City Council meeting; alternatively if Barbara Sally is not interested, to solicit applications to fill the vacancy for the purpose of conducting interviews on August 14, 2018 with a deadline to submit said applications by the date agenda items are due.
