## Department Recommendation:

Staff recommends that City Council consider options pursuant to Elections Code §10229 as they pertain to the District A, B, and E seats. One option is to adopt Resolutions 2020-36; 2020-37; and 2020-38 providing for the appointment of Dave Hails, District A; Barbara Sally, District B; and an Eligible Elector, District E to the Office of Exeter City Council. Dave Hails and Barbara Sally may be re-appointed to their seats, as they are the sole qualified candidates in Districts A and B. An eligible elector may be appointed for the District E seat, because no qualified candidates filed for the seat in District E. The person(s) appointed, if any, shall qualify and take office and serve exactly as if elected at a municipal election for the office. Alternatively, the Council may proceed with the election for any or all of these seats.

### Summary:

An option to appoint instead of election is available pursuant to California Elections Code §10229, if only one nominated candidate in each district exists. If the Council chooses to make appointments in lieu of an election, this will result in a cost savings to the City in not having to incur the printing and administration costs of including those candidates on the ballot. However, if the City Council makes an appointment as allowed by statute, the City Clerk would not accept for filing any statement of write-in candidacy which is submitted after the appointment is made.

### Background:

The Candidate Nomination Filing Period for the November 3, 2020 General Election was July 13 through August 7. As of the close of the nomination period on Friday, August 7, 2020, the only qualified nomination papers received for District A were filed by Dave Hails and for District B were filed by Barbara Sally and none were received for District E.

Pursuant to Elections Code §10229, the City elections official shall submit a certificate of these facts to the governing body of the city and inform the governing body of the city that it may, at a regular or a special meeting held before the municipal election, adopt one of the following courses of action:

- (1) Appoint to the office the person who has been nominated.
- (2) Appoint to the office any eligible elector if no one has been nominated.
- (3) Hold the election, if either no one, or only one person has been nominated.

A notice of the facts described was published in a newspaper of general circulation, The Sun-Gazette, pursuant to Government Code §6061 on Wednesday, August 12, 2020.

In District A and B, options (1) or (3) are available. In District E, options (2) or (3) are available because no person has been nominated. The City published on its website and Facebook page on August 12, 2020, that Eligible Electors that are registered voters in the City of Exeter and reside in District E and are interested in serving for the term ending in November 2024, to submit a letter of interest for consideration by Tuesday, August 18, 2020 at 12:00 p.m. At the meeting, the Council can consider any letters of interests submitted for District E, conduct interviews of those that are interested, and, if they would like, proceed with appointing to office any eligible elector. Any appointed council members will be installed after the November election, no later than the next regularly scheduled meeting following the presentation of the 28-day canvass of returns.

If the proposed Resolutions are adopted and appointments made, a certified copy of said Resolutions will be forwarded to the Tulare County Registrar of Voters Elections Office as notice of cancellation of the November 3, 2020 Election for City of Exeter Districts A, B, and E.

Pursuant to Elections Code §10229, the deadline for appointment in-lieu of election is August 20, 2020. Therefore, this special meeting was required to meet this deadline.

### Financial Impact:

By cancelling the election and proceeding with appointment, the election costs will be reduced. An exact amount will not be known until early next year when invoices are submitted for payment by the Elections office but based on previous elections could be in the range of \$2,000.00 to \$3,000 per candidate. The set-up costs for the elections will still have to be paid for these districts.
