### **INSURANCE:**

#### **Auto Liability**

Participant shall provide evidence of auto liability coverage for owned, non-owned, and hired autos at least as broad as ISO Business Auto Coverage form CA 00 01. *(This requirement applies to any autos used in the event, including those used as floats and display vehicles during the parade)*

### **WAIVER, RELEASE AND INDEMNITY AGREEMENT**

*In consideration of the acceptance of my application for participating for the above event, I, for myself and/or on behalf of my child, hereby waive, release, and discharge any and all claims for damages for death, personal injury, or property damage which I may have, or which hereafter accrue to me, against the City of Exeter as a result of my participation in the event. This release is intended to discharge the City of Exeter, its officers, officials, employees, and volunteers, any other involved municipalities or public agencies from and against any and all liability arising out of or connected in any way with my participation in the event, even though that liability may arise out of the negligence or carelessness on the part of persons or Entities mentioned above. I, for myself and/or on behalf of my child further understand that accidents and injuries can arise out of the event; knowing the risks, nevertheless, I hereby agree to assume those risks and to release and to hold harmless all of the persons or agencies mentioned above who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assigns.*
