H. CONSENT CALENDAR:

It was moved by Mayor Pro Tem Mills, seconded by Council Member Sally, and unanimously, carried that the items on the Consent Calendar be approved as presented.

- 4. Award and authorize the City Administrator to execute an agreement with Pavement Coatings Co., of Sacramento, CA in an amount of \$398,628.95 for construction of the 2023 Cape Seal and Micro Surfacing Project and authorize a 10% contingency amount (\$39,863.) for potential extra work.
- 5. Authorize the City Administrator to enter into a purchasing agreement with Crafco Inc., of Fontana, CA for the purchase of one (1) K M International 4-Ton Trailer Mounted Diesel Hot Box, in the amount of \$39,247.63.
- 6. Award and authorize the City Administrator to execute an agreement with Tally Oil, Inc., of Madera, CA in an amount of \$96,364.80 for construction of the 2023 Reclamite Project and authorize a 10% contingency amount (\$9,636.) for potential extra work.

Adopt Resolution 2023-08 authorizing the City Administrator to execute Agreements with the California Department of Transportation for the City of Exeter's Reactivating Exeter's Public Spaces (REPS) Project for the Clean CA Local Grant Program and provide direction to staff regarding the proposed project. Public Works Director Daymon Qualls introduced Sheela Bhongir of Tulare County Association of Government. Ms. Bhongir provided information regarding the Clean CA Local Grant Program. Council Member Riddle recused herself from this item due to owning real property near the proposed improvements and exited the room. Mr. Qualls provided a PowerPoint report highlighting City of Exeter's Reactivating Exeter's Public Spaces (REPS) project.

Following discussion, it was moved by Council Member Sally, seconded by Mayor Pro Tem Mills and carried 4-0 (Council Member Riddle recused) to adopt Resolution 2023-08 authorizing the City Administrator to execute Agreement with the California Department of Transportation and provided direction to move forward.
