# EXETER CITY COUNCIL ACTION MINUTES

May 23, 2023

A regular session of the City Council, City of Exeter was held on Tuesday, May 23, 2023, at 7:00 p.m., in the Exeter City Council Chambers, 137 North F Street.

#### A. CALL TO ORDER REGULAR SESSION

Mayor Alves called the regular session to order at 7:00 p.m.

### E. CONSENT CALENDAR:

It was moved by Council Member Sally, seconded by Council Member Riddle, and unanimously carried that the items on the Consent Calendar be approved as presented.

- 4. Authorize the outfitting of two police vehicles with emergency equipment through Cook's Communications of Fresno, CA. in the amount of \$22,399.52.
- 5. Authorize City Administrator to execute an Amendment No. 1 to renew an agreement with Avenue Insights & Analytics, LLC of Centreville, VA, for financial systems application hosting and technology services for period from July 1, 2023, through June 30, 2026 in the amount of \$122,317.68, subject to minor conforming and clarifying changes acceptable to the City Attorney.
- 6. Adopt Resolution 2023-16 Supporting California Senate Bill 14, which would include human trafficking of a minor within the definition of a serious felony for all purposes, including for purposes of the Three Strikes Law.

# F. INDIVIDUAL BUSINESS ITEMS:

- 1. Public Hearing to introduce and give first reading of Ordinance 712 Amending Title 17 of the Exeter Municipal Code by adding text amendments to Chapter 17.64 to add "Accessory Dwelling Units" as a section of the Special Uses Chapter. Assistant City Planner, Tristan Suire provided a report for Council's review and consideration. Mayor Alves opened the floor to public comment at 7:32 p.m., receiving none, closed the public comment at 7:32p.m. Council posed questions and Mr. Suire provided a response thereto. Following discussion, it was moved by Mayor Pro Tem Mills, seconded by Council Member Sally and unanimously carried to introduce and give first reading of Ordinance 712 Amending Title 17 of Exeter Municipal Code by adding text amendments to Chapter 17.64 to add "Accessory Dwelling Units" as a section of the Special Use Chapter, read by title only, and waiving further reading in full. City Attorney Julia Lew read the Ordinance by title only.
- 2. Adopt Resolution 2023-17 Appointing Rene Miller as Interim Finance Director, Approving Employment Agreement and authorizing the City Administrator to execute same subject to minor conforming and clarifying changes acceptable to the City Attorney. City Administrator Adam Ennis and City Clerk/ Human Resources Manager Shonna Oneal provided a report for Council's review and consideration. Following discussion, it was moved by Council member Sally, seconded by Council member Riddle and unanimously carried to adopt Resolution 2023-17 as presented and to authorize the City Administrator to execute the Employment Agreement subject to any minor conforming and clarifying changes acceptable to the City Attorney.

#### G. CITY COUNCIL ITEMS OF INTEREST

Council discussed items of interest. Mayor Pro Tem Mills requested an item be agendize for the next meeting regarding mid-term improvements for safety at City Park. It was the consensus of the Council to add the item requested.
