Department Recommendation:

Summary/Background:

The Planning Commission plays a critical role in land use planning, development review, and ensuring that community growth aligns with Exeter's long-term goals. Commissioners are tasked with:

- Decision-Making: Reviewing, approving, or recommending actions on development projects, conditional use permits, variances, zoning changes, and subdivisions.
- Advisory Role: Making recommendations to the City Council regarding the General Plan, zoning ordinances, and other planning policies.
- Community Stewardship: Acting in the best interests of the community by balancing growth, sustainability, economic development, and quality of life.
- Ethics and Conduct: Abiding by state and local laws regarding conflicts of interest, open meeting requirements (Brown Act), and ethical standards.
- Preparation and Participation: Reviewing staff reports and application materials in advance, attending scheduled meetings, and engaging constructively in deliberations.

This item is not an action item, but rather an informational review and discussion to ensure all Commissioners are aligned in their understanding of roles and expectations moving forward.

Exeter Planning Commission

Section 2.16.010 – Members – Appointment

The Planning Commission consists of five members appointed by the Mayor with the approval of the City Council. Members must not be seated City Council Members.

Section 2.16.020 – Terms

Commissioners serve staggered four-year terms. Appointments are made to fill vacancies resulting from term expirations or other causes.

Section 2.16.030 - Duties

The Planning Commission is tasked with duties outlined by state law and local ordinances.

Chapter 16.12.050 – Planning Commission as Advisory Agency

The Commission acts as the City's advisory agency under the Subdivision Map Act, reviewing tentative maps and providing recommendations on subdivision matters.

Chapter 17.03.03 – Final Authority on Site Planning and Use Classification

The Commission holds authority on site plan reviews, classification of uses, and other key development review procedures, and also makes recommendations to the City Council on zoning ordinance amendments, general and specific plans, and development agreements.
